In the July-August-September 1997 edition of this newsletter, Sandra Todd published an article titled "More Vermilyea-Vermilya-Vermilye Addresses." It was a listing of six roads bearing the name Vermilya or Vermilyea. Included on the list were Vermilya Avenue in Flint, Michigan, and Vermilya Road in Columbiaville, Michigan.

In August 1998, Linda and I went to Michigan to attend the wedding of one of her relatives. Hoping we might have some time to hunt down those road while there, before leaving I printed out two maps of the area from my computer. On Sunday we found some time and, armed with the maps, headed off on our quest. We found the roads; and, much to our surprise, we also discovered two more places, the Vermilya School and Vermilya Park.

Often, historical or genealogy research on a Sunday is not very productive because

libraries, historical societies and town/city offices are closed. That was the case here. In the small, rural village of Columbiaville, we found a helpful convenience store clerk who gave us the address of the local historical society. Upon returning home, I wrote them. The reply came from Robert ("Bob") Blue (VFA #429-II-2-a), a "shirt-tail" cousin and retired school teacher living in Saginaw, Michigan. Bob had been born and raised in Columbiaville and was the author of "A History of the Columbiaville Area," published in 1979. In a word, jackpot! He turned out to be a wealth of information.


Bob informed me that the school, park and both roads were named after descendants of Jonathan Vermilya (VFA #179). Jonathan, born in 1795 in New York State, moved to Brantford Township, Ontario, Canada, where in 1820 he married Margaret Petrie. Around 1855, the couple with most of their 13 children, including Edward (#421), Anne (#423), Elijah (#427), and Emily (#429) who was Bob Blue's ancestor, moved to Columbiaville and settled on a farm about a mile west of town. At the time, Columbiaville was heavily forested; the principal occupation was logging. Cleared areas became farms. Within a few years, Jonathan and Edward staked abutting 40-acre homesteads about a mile south of their first residence where they built homes and began farming. A trail into their property was later named North Lake Road. Jonathan passed away in 1870.

With that general background, following is what we found in 1998 together with the information provided by Bob about the four Vermilya places.

Vermilya Avenue, Flint, Michigan: Vermilya Avenue in Flint was named in honor of Edward J. ("Ned")
Vermilya (#1176) who was born in 1886 and passed away

in 1953. Ned, who served as the City Clerk of Flint from about 1930 to about 1950, was the son of Harmon Vermilya (#779) one of Edward's four children.

Located on the south side of Flint, Vermilya Avenue is easy to find. It is located a block west of Route I-475, about 1.3 miles south of the junction of Route I-69. It is an east-west, 0.9 mile long, two-lane, city road, in a large, fairly-well maintained neighborhood-development of nearly similar, very modest, single, small, almost square, framed, one story homes which appear to have been built primarily to house factory workers after World War II. The most prominent building along the Avenue is an

Now, as we recognize our 6th anniversary and enter our 7th year, we find we have 93 families subscribing to our newsletter. Not bad for a small family like ours. Can we make it 100 members in 2002? We can if you help by further spreading the word.

This is the last issues of our newsletter before annual memberships expire for most of us. We'd like to receive your renewal as soon as possible. Why not take a minute now and write your check for next year's dues. But first, please read the article in this edition about membership. There you'll find a listing of members who have already paid through the next two years.

Recognizing that there are many descendants in Canada who might join our Association if we made paying dues easier for them, the Board of Directors, after taking in consideration the exchange rate and newsletter postage difference, has set dues in Canadian currency for 2002 at \$17.20. Now, Canadians may write checks on their personal Canadian banking accounts or purchase Canadian money orders for that amount and mail them off to our Treasurer, Daly Stout. (Note: Dues in 2002 for USA residents are \$12.00, just as they have been in past years.)

Thanks to the efforts of Veronica Theodorakis, we are now able to provide back issues/editions of this newsletter. This new service enables the VFA to set one dues rate for the year and, for anyone whose membership is current, to order any back issue of the newsletter. Please look for details in this issue.

The 2002 Reunion previously scheduled to be held at the St. Francis Retreat in San Juan Bautista, California on August 19-21, 2002 has been canceled. Understandably with the untimely events of September 11th, we did not receive sufficient reservations to reserve the Retreat. We are exploring other options and, if an alternative is found, we will post information at our web site and in the next edition of this newsletter.

Eugene Ward (Steve) Vermilyea (#1337). Murray County News, August 29, 2001: Steve Vermilyea was born on April 3, 1925, on a farm near Bronson, Iowa to Robert and Bessie Cisne Vermilyea. He grew up on the family farm, attended country school and graduated from Climbing Hill High School in 1943. He was drafted into the U.S. Army and served in the European and African Theaters during WWII. Following his discharge, he returned to Sioux City and worked for Charlie Miller Body Shop. He married Helen Holmes on November 11, 1950, in Elk Point, South Dakota. Steve continued working at the body shop for a short time before they moved to Sloan, Iowa. He owned and operated Vermilyea Body Shop until his retirement. He also farmed for several years. Steve and Helen spent summers at their home on Lake Shetek at Slayton, Minnesota. Following Helen's death in April 1981, Steve made Lake Shetek his permanent residence. On December 15, 1984, he and Karen McClain were married and they continued to make their home there. Although his health was failing. Steve was able to stay at home. He was a resident of the Slayton Manor for a few days before he passed away there on August 21, 2001 at the age of 76. He was a member of the Currie American Legion Post. Steve enjoyed fishing, playing cards and restoring his old cars. Survivors include his wife Karen Vermilyea, four daughters and their husbands: Patricia and Jerry Johnson; Christine and Art Drossel; Pamela and Jeff Crull and Joan and Lloyd Tresham; eight grandchildren; one great-grandson; and three sisters: Ruth Klasey; Ardith and her husband Bob Anderson and Joyce Binns. attractive, large, stone-exterior, Methodist Church located at its intersection with Fenton Road.

Vermilya Road, Columbiaville, Michigan: Columbiaville is a small, rural town about 45 minutes drive northwest of Flint. We were glad we had the map from the computer. It not only helped us find Columbiaville but also Vermilya Road which, as it turned out, had no street name sign on either end.

To reach Vermilya Road from Columbiaville, we drove westerly for .8 of a mile along Columbiaville Road from its beginning at the junctions of Second and River Streets in the village. We

then turned left (south) on North Lake Road, a dirt road. At the one-mile point, North Lake Road ends in a three-way junction with Pyles Road and Vermilya Road, flat, hard packed, all-weather, dirt roads. Although we did not know it at the time, we had just passed through the homestead once owned by Jonathan Vermilya. His home, which had been located on the west side of the road, was razed in about 1950.

In 1998, this north terminus of Vermilya Road was posted with a large, foreboding, black-on-white hand-painted sign saving: "Road Closed." Although tempted to drive along it, I decided to try entering it from its other end. We drove westerly along Pyle Road for about one mile and took a left (south) on Catlin Road. At the .65 mile point, we found that Vermilya Road branches easterly off Catlin Road. Again unknown to us at the time, we were driving through, or around, the former homestead of Edward Vermilya. On the Catlin Road end of Vermilya Road, the town had installed a dead-end sign, but no street name sign. Despite the sign, we drove in. We knew we were in the right place when we saw the road's name printed on the road-side mail box of the first home we passed. We traveled only about 0.4 of a mile before the road narrowed to a two-tracked trail (a fire road). We stopped there. From our map and what we could see, the trail meandered from there northeastward for another .8 mile and then turned northward paralleling the Hollaway Reservoir for .4 of a mile where it termi-



nates at the above mentioned junction with North Lake and Pyles Roads. The land in the area is flat and has many young trees; obviously formerly farm land. We did not see a home which might have belong to Edward. Perhaps it was located on the section of Vermilya Road we did not drive along or maybe it had been razed as had been his father's home. Along the short stretch we did travel, there were three modest homes of varying styles and the Vermilya School (see below).

Roads in the area were not named until the Rural Electrification Administration (REA), formed under President F. D. Roosevelt, encouraged utility companies to extend their services into rural areas.

In the 1930s, Detroit Edison installed lines in Columbiaville. The company conferred with local town officials for advice in naming roads and, in many instances, the roads were named after early land owners. It this case, Vermilya Road ran through Edward Vermilya's homestead and aside the road was the Vermilya school; hence, the name.

Vermilya School, 5459 Vermilya Road, Columbiaville, Michigan: As we entered Vermilya Road from Catlin Road, we immediately noticed on the left an old, nearly dilapidated building which, at first glance, looked like a small barn or farm out-building. Linda spotted a rusty, metal sign over the door. We stopped and got out to read it. Much to our surprise, the sign read Vermilya School. Next to the door were numbers, the street address. As there was no record of the school in any genealogy documents the VFA had, we were thrilled to make this discovery.





The once dark-stained, wood-framed, one-room schoolhouse is very weathered and in major disrepair. Through cracks in the boarded up windows we could see it was empty save a few old pieces of wood and some old farm tools. According to Bob Blue a County Plat shows that the school was in existence in 1874 and definitely was on part of Edward Vermilya's farm. Presumably the land was donated by him to the town for the school. It is believed that the original school building was probably a rude log cabin, as was customary, and later replaced by the current building. One of the earliest, if not the first, teachers at the school was Porter Murphy who was married to Anne (Vermilya)

Markle's daughter, Melissa (#423-I). Town records show that in the mid-1890s, Methodist Church services were held in the building. The school closed in 1954 when rural schools throughout the area consolidated with local village schools to form the Lakeville School District. Thereafter, the building was not used for any purpose by the town and, most likely, ownership of it reverted to the then owner of what was originally Edward's farm.

Vermilya Park, Columbiaville, Michigan: Having found Vermilya Road and School, we returned to the village of Columbiaville. Within a short period of time we had driven along most of the streets. We saw the closed library and town offices, the elementary school and, nearly across the street from the school on Pine Street between Fourth and Fifth Streets a park/athletic field which turned out to be Vermilya Park.

The Park is named after Albert ("Bert") M. Vermilya (#1177) who was born in 1893 and died in 1981. Bert was the grandson of Elijah Vermilyea and son of Charles Vermilya (#788). He was a sign maker and, with his brother Curt, owned and operated for over 50 years Vermilyea Brothers Florists. He served Columbiaville as village Treasurer from 1926 through 1928, Trustee in 1929 and 1930 and President from 1949 to 1956. He was a charter member of the Columbiaville Historical Society and also of the Columbiaville Rotary Club which was established in 1947. In 1976, the Rotary Club rejuvenated a former baseball field owned by the village by constructing on it a playground, band stand and pavilion; and, named it in honor of Bert.

Our visit to these four Vermilya places took only about three hours. I'd recommend the trek to anyone living in or passing through Michigan. If you do go to Flint and or Columbiaville, the VFA would appreciate a report of your observations covering any of these places, especially an update on the status of the school.


